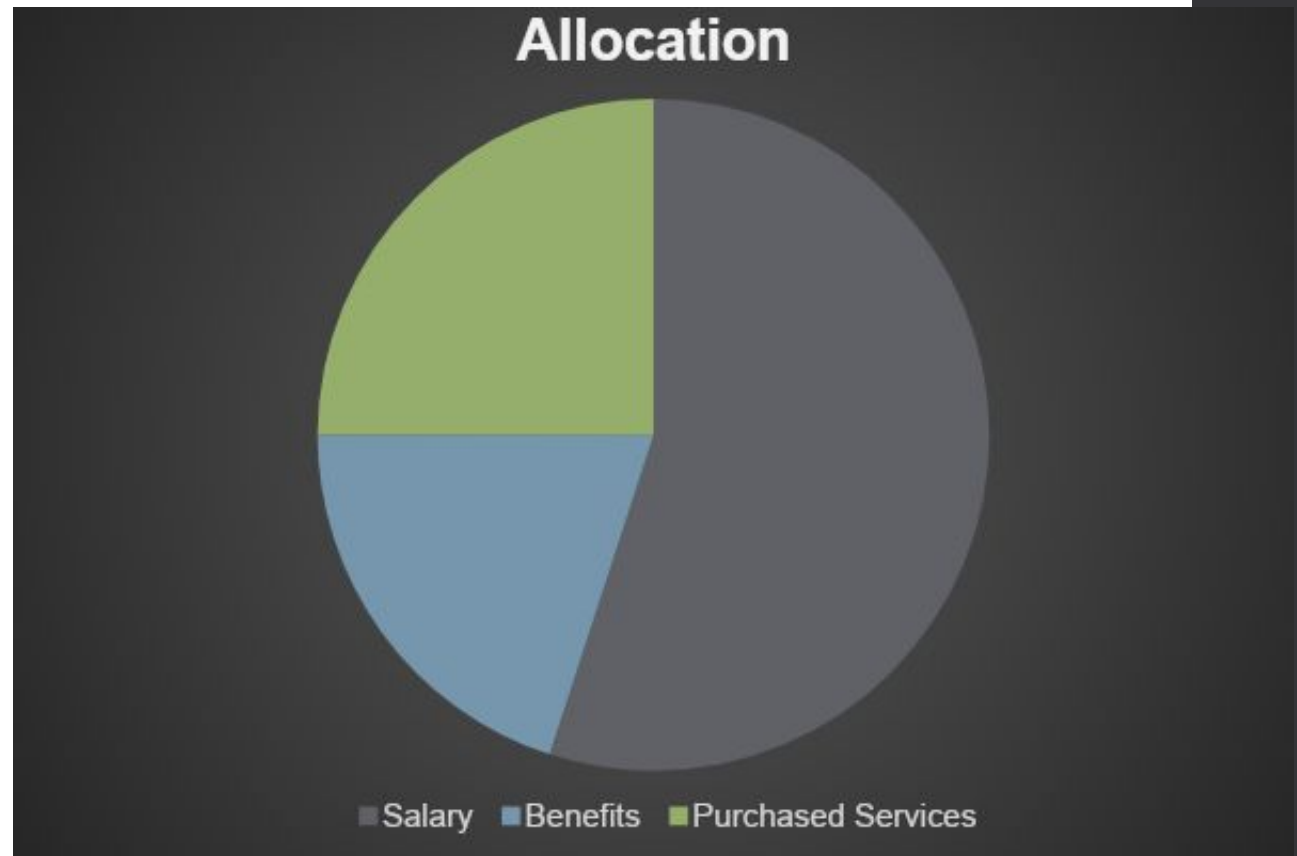

- Entitlement Funds that are provided to PLSD through the US Department of Education
- Title I, IIA, III, IDEIA, Part B and Early Childhood Special Education
- Fiscal Year FY21 (June 1, 2020-June 30, 2021)
- Actual allocations will be finalized by June 30, 2021 for the next school year

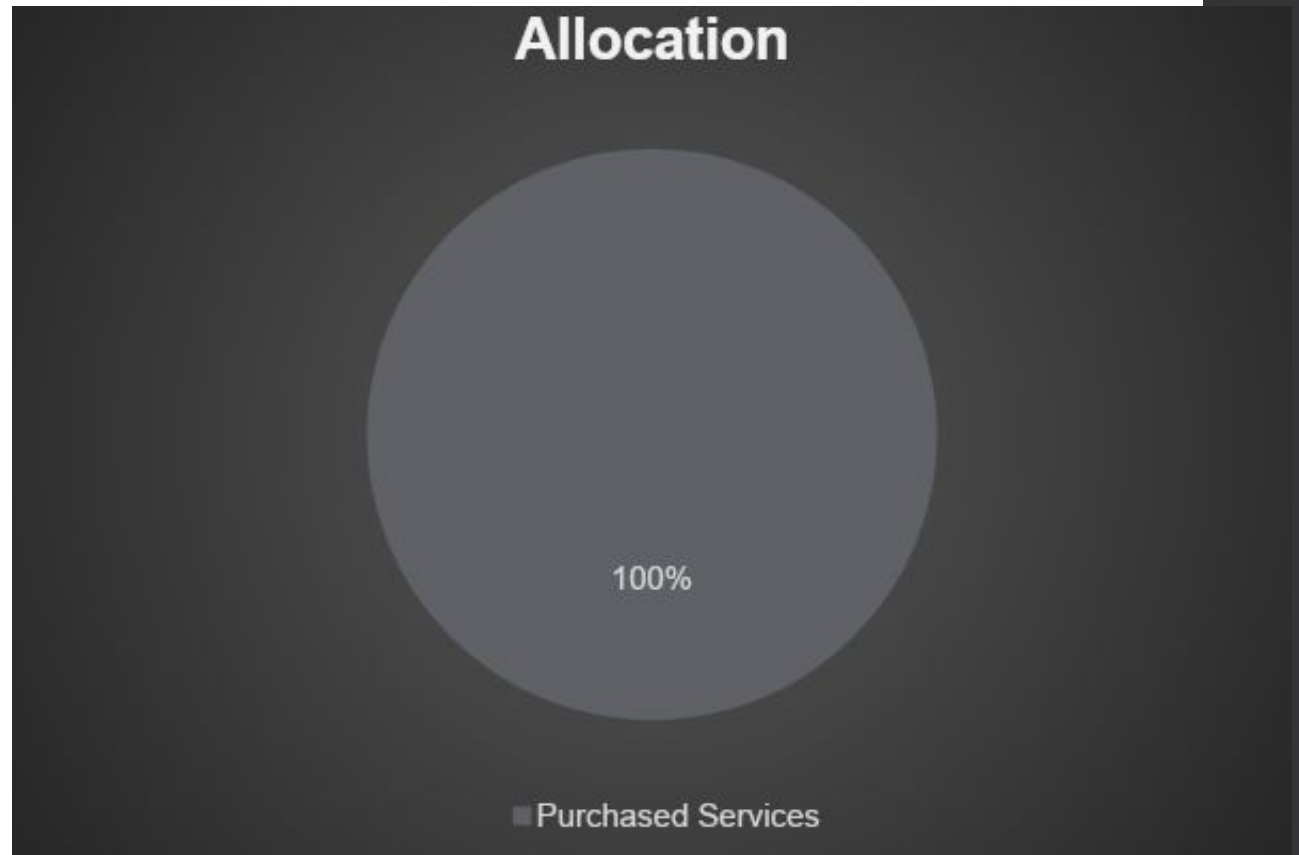
Special Education Part B-IDEA

- **Purchased Services - \$0**

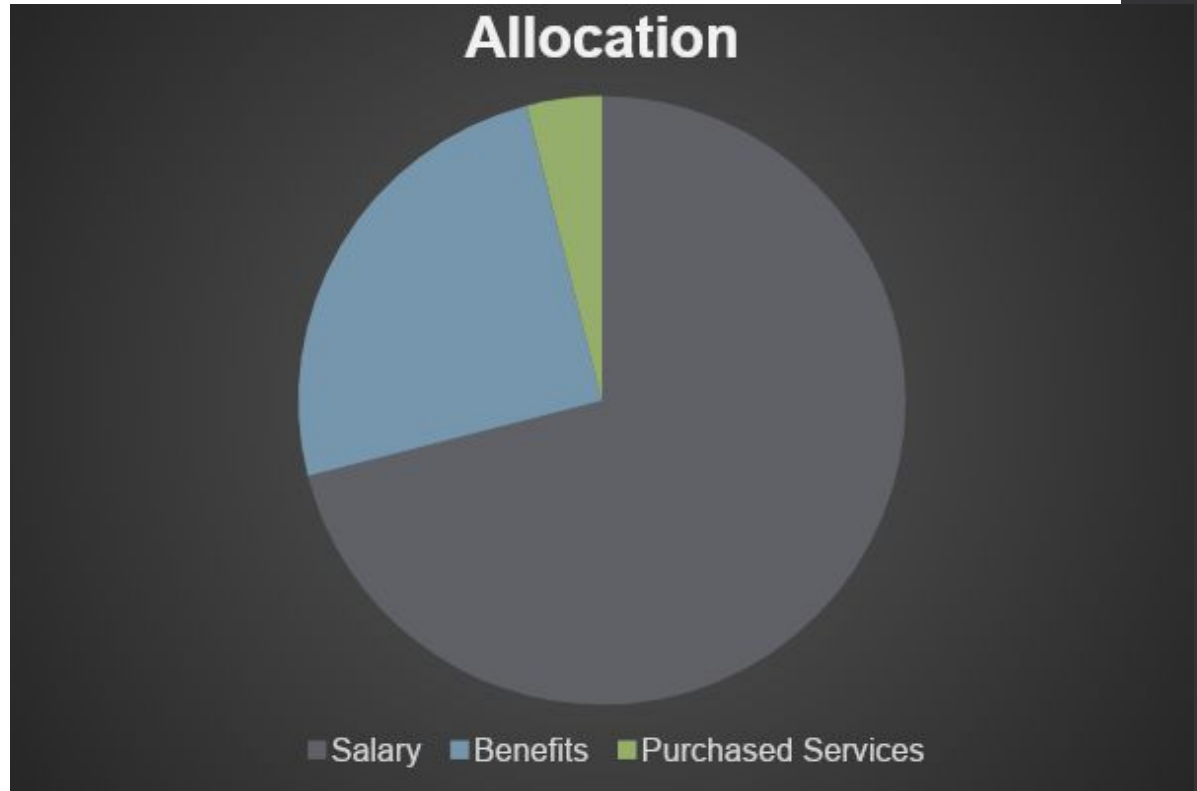


Special Education: FY22 Proposed Use of Federal Funds

- Continue Step Up to Quality requirements for professional development to ensure the district is eligible to apply for a 5-star rating.
- Provide opportunities for professional development for intervention specialists, related services staff, support staff and general education teachers in best practices, crisis intervention and software updates.
- Contract services with a behavioral consultant in order to address behavioral needs of students with moderate to intensive disabilities.

Title I, Part A

- **Total Allocation** - \$179292.24 plus transfer from Title IIA 42907.65
- **Title 1 teachers**
 - 2 at Furry Elementary
 - 1 at Meadowlawn Intermediate School
- **Purchased Services (Non-public students served at Sandusky Central Catholic) - \$20,507.82**
- **Salaries & Benefits - \$201,692.07**
- **All Title IIA funds are transferred to Title I, Part A**
- **Title IIA funds are utilized to improve teacher quality**



Title I, Part A Proposed Use of Federal Funds FY22

- Continue to provide salaries and benefits for Title I teachers so they may provide direct intervention to students K-5.
- Supplemental Instructional Materials for Students
- Family Engagement Activities at school.
- Professional Learning Support to teachers and administration to impact student achievement.
- Support services to maintain compliance administration of the funds.

Title III Program English Learners (EL) Proposed Use of Funds FY21

- Students in grades K-12 are eligible for Title III services in all of the schools in the Perkins Local School District.
- Providing funding for mentors, support staff, instructional materials, and professional learning.
- PLSD has a population with >1% of EL students.
- Total Allocation - \$1115.40 – all sent to Lorain Co ESC for programming

Title IVA Funds

This new federal grant provides districts with funds towards building capacity to ensure that all students have access to a high quality educational experiences.

- FY21Allocation - \$20,350.17
- Salaries & Benefits – \$7,840.17
- Purchased Services - \$0
- Supplies/equip - \$12,510.00

PLSD and Federal Programs
